



CAISTER PARISH COUNCIL CEMETERY

TABLE OF FEES FROM 1 APRIL 2024

*The fees, payments and sums set out below apply where the person to be interred or in respect of whom the right is granted, is **or immediately before his death**, was an inhabitant of the Parish of Caister-on-Sea, or in the case of a still-born child, where one of the parents is, or at the time of interment, was such an inhabitant or Parishioner of Caister-on-Sea.*

***In all other cases**, the fees, payments and sums will be double except that those set out in Parts 1 and 3 will not be doubled where the Exclusive Right of Burial in the grave in question, was acquired at the single fee as set out in Parts 2 .*

The fees indicated for the various heads of items, 1, 2 include the digging of the grave.

PART 2 – EXCLUSIVE RIGHT OF BURIAL IN EARTHEN GRAVES

(a) For the exclusive right of burial in an earthen grave 9 feet by 4 feet (for single plots in re-usable ground)

£280.00

For the exclusive rights of burial in an earthen grave 9 feet by 4 feet (this is for side by side plots in re-usable ground) as graves can only be dug to single depth)

£550.00

(b) For the exclusive right of burial of cremated remains in an earthen grave 2 feet by 2 feet

£120.00

PART 3 – MONUMENTS AND MONUMENTAL INSCRIPTIONS

For the right to erect or place on a grave or vault in respect of which the Exclusive Right of Burial has been granted.

(a) A headstone not exceeding **3 ft.** in height

£200.00

Headstone of **2 ft.** in height **ONLY** to be erected in the "Ashes Section".

£200.00

(All bases for headstones not to exceed:- (24" x 12" x 4"))

(b) A flat stone

£150.00

(c) A monument in the form of a book, flower vase or scroll not exceeding 12 inches in height.	£150.00
(d) An additional inscription or replacement headstone	£100.00
(e) Transfer of Exclusive Rights to new owners.	£100.00
Living Transfer to new or additional owners	£30.00

Double the amount of the above fees will be payable in respect of non-parishioner and non-habitant not dying within the area for which the burial ground is provided.

"A PERSON WHO HAS LIVED OUTSIDE THE BOUNDARY OF CAISTER -ON-SEA, AT THE TIME OF DEATH, FOR OVER FIVE YEARS, IS NOT ELIGIBLE TO BE BURIED OR ASHES INTERRED IN THE VILLAGE CEMETERY." *Ruling applies to new graves only.*

EXCLUSIVE RIGHTS OF BURIAL TO BE PURCHASED AT TIME OF BURIAL – THIS APPLIES TO NEW GRAVES (NOT CHILDREN) - under the age of 18 years

NO RESERVATIONS ALLOWED IN CEMETERY – Ruling passed by committee 1987
